Notice is hereby given that sealed proposals addressed to the Business Administrator will be received on or before **Thursday, August 20<sup>th</sup>, 2015**, at **11:00 A.M.**, prevailing time, at which time they will be opened and read at the West Windsor Township Municipal Building, 271 Clarksville Road, Princeton Junction, New Jersey for the work described below.

Specifications, plans and bid documents will be available on or after **Thursday, July 23<sup>rd</sup>, 2015**, at **11:00 A.M.**, and may be examined from the Administration Department located in the West Windsor Township Municipal Building during regular business hours, 9:00 AM to 5:00 PM, Monday through Friday excluding holidays or obtained upon a non-refundable deposit of \$50.00 per set. Check shall be made payable to West Windsor Township.

Bids must be submitted on the prescribed form, in a sealed envelope marked:

**COMMUNITY PARK PLAYING FIELD - CRICKET PITCH, IRRIGATION AND SOD**

The work under this contract includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in the contract documents.

The Base Bid includes construction of a 10-ft. x 90-ft. cricket pitch with reinforced concrete base, artificial turf, bituminous concrete walk, regrading of the outfield, irrigation, sodding, seeding and fertilizing, and other incidental work as necessary to complete work. There is an Alternate Bid that includes a second cricket pitch with reinforced concrete base and artificial turf.

Quantities include, but are not limited to, approximately 1 cricket pitch; 100 SY artificial turf; irrigation system; 4,000 SY sodding; 23,250 SY fertilizing and seeding, and other incidental work.

A bid deposit in the form of a certified check, cashier's check, or bid bond made payable to the Township of West Windsor in the amount of ten percent (10%) of the total amount of the bid, but not to exceed \$20,000.00, must accompany each proposal as a security, which may be forfeited and retained by the Township in lieu of its other legal remedies, if a successful bidder's proposal is accepted by the Township and he shall fail to execute and return to the Township the required contract and/or bonds within ten (10) days after delivery of the prepared contract and/or bond form to him by the Township.

The Township Council reserves the right to reject any or all proposals in whole or in part to waive such informalities as may be permitted by law.

Bidders are required to comply with the requirements of **P.L. 1975, C. 127** and **N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27**.
