Notice is hereby given that sealed proposals addressed to the Business Administrator will be received on or before **Thursday, August 31, 2017**, at 11:00am, prevailing time, at which time they will be opened and read at the West Windsor Township Municipal Building, 271 Clarksville Road, Room A, Princeton Junction, New Jersey for the work described below.

Specifications, plans and bid documents will be available on or after **Monday, July 31, 2017**, at 11:00 am, and may be examined from the Administration Department located in the West Windsor Township Municipal Building during regular business hours, 9:00 AM to 5:00 PM, Monday through Friday excluding holidays or obtained upon a non-refundable deposit of \$50.00 per set. Check shall be made payable to West Windsor Township.

CRANBURY ROAD SIDEWALK PROJECT – PHASE I

The work under this contract includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in the contract documents.

The Base Bid includes clearing the site, excavating and grading the site for sidewalk construction, construction all courses of porous asphalt sidewalk, constructing bituminous driveway aprons, removing and reconstructing select curb, sidewalk, and handicap ramps, striping and signage and pavement markings, other incidental work and traffic control as necessary to complete the work.

Quantities include but are not limited to approximately construction of 4,000 SF of porous asphalt sidewalk, construction of 1,000 SF of bituminous driveway construction with dense graded aggregate base, 200 LF of 4" wide thermoplastic striping, lump sum costs for site clearing, soil erosion/sediment control, and earthwork/grading, and other incidental work.

A bid deposit in the form of a certified check, cashier's check, or bid bond made payable to the Township of West Windsor in the amount of ten percent (10%) of the total amount of the bid, but not to exceed \$20,000.00, must accompany each proposal as a security, which may be forfeited and retained by the Township in lieu of its other legal remedies, if a successful bidder's proposal is accepted by the Township and he shall fail to execute and return to the Township the required contract and/or bonds within ten (10) days after delivery of the prepared contract and/or bond form to him by the Township.

The Township Council reserves the right to reject any or all proposals in whole or in part to waive such informalities as may be permitted by law.

Bidders are required to comply with the requirements of **P.L. 1975, C. 127 and N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.**
