Mayor/Administration:

2019 Flu Shot Program

Ms. Swanson reviewed the new flu shot program that will be done this year in conjunction with Wegmans Pharmacy. She advised that Wegmans will provide the normal flu vaccine, the high dose flu vaccine, and the pneumonia shot to residents. Ms. Swanson noted that this is a pilot program and will be evaluated in early 2020.

Ms. Geevers inquired if there are any costs for the Township associated with this program.

Ms. Swanson advised that only in the case of someone not having insurance will the Township pick up the cost of the flu shot at the pharmacy cost.

President Miller advised that this is a good program.

Ms. Swanson noted it is a "Best Practice" to vaccinate uninsured senior residents.

President Miller advised that she received an answer on the chemicals in question that Ms. Lin had asked about and advised that this type of foam is used primarily on military bases.

Ms. Swanson reported that regarding measles, as with any communicable disease the Health Department has a specific protocol to follow. She advised that all of this is done through an electronic reporting system. Ms. Swanson advised that the Public Health Nurse contacts the schools as well as local pediatricians regularly.


PUBLIC COMMENT
