The Township encourages prospective bidders to submit their sealed proposals prior to Wednesday, September 9, 2020 via certified mail or overnight delivery along with requiring a signature. West Windsor is not responsible for bids which are sent for delivery and not received by a municipal employee. At conclusion of the public bid opening and after review from Municipal personnel, the bid results along with the pertinent documents of the apparent three low bid submissions will be scanned and posted on the Municipal Website within 48 hours, www.westwindsornj.org.

Specifications, plans and bid documents will be available on or after **Monday**, **August 17**, **2020**, **at 10:00 am**, and may be examined from the Administration Department located in the West Windsor Township Municipal Building during the hours of, 10:00 A.M. to 4:00 P.M., Monday through Friday excluding holidays or obtained upon a non-refundable deposit of \$50.00 per set.

Please follow instructions posted at the front entrance of the Municipal Building if picking up and/or reviewing the bid packages in person as they will direct you on the proper procedure for maintaining physical distancing requirements.

The only acceptable methods of payment are cash or a physical check and/or money order. Check shall be made out to **West Windsor Township**. Scanned checks are not acceptable. Mailed checks must include a request for documents with the name of the requested solicitation, as well as the Company Name, Mailing Address, Telephone and Facsimile Numbers as well as Contact Person's Name & Email address. A FedEx number must be provided in order for West Windsor to ship the documents. Cash payments must be submitted in the exact amount.

The work under this contract includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in the contract documents. This work is funded partially or wholly with a New Jersey Department of Transportation grant and is subject to any and all requirements which shall attach.

The Base Bid includes but is not limited to soil erosion and sediment control, site clearing, traffic maintenance and protection, approximately 20,430 SY of milling, 2,830 250 TN of 9.5M64 surface course, 250 TN of 9.5M64 leveling course, 145 SY of 19M64 base course, 300 LF concrete curb, 200 LF Belgian block curb, 7,833 SF concrete sidewalk, 145 SY dense graded aggregate base course, traffic control, 6,550 LF crack sealing, 10,065 LF thermoplastic traffic stripes (various widths), 169 units tree trimming (6" – 36" diameter), 3,040 SY seal coating, 445 LF joint sealing (rubberized asphalt), 1,745 SY topsoil (fertilize, seed and mulch).

The Add Alternate Bid quantities include but are not limited to 3,040 SY milling (additional), 410 TN Hot Mix Asphalt 9.5M64 surface course (additional) as well as elimination of base bid quantities for crack sealing and seal coating.

A bid deposit in the form of a certified check, cashier's check, or bid bond made payable to the Township of West Windsor in the amount of ten percent (10%) of the total amount of the bid, but not to exceed \$20,000.00, must accompany each proposal as a security, which may be forfeited and retained by the Township in lieu of its other legal remedies, if a successful bidder's proposal is accepted by the Township and he shall fail to execute and return to the Township the required contract and/or bonds within ten (10) days after delivery of the prepared contract and/or bond form to him by the Township.
