Notice is hereby given that sealed proposals addressed to the Business Administrator will be received on or before Tuesday. November 21, 2023, at 2:30 pm, prevailing time, at which time they will be opened and read at the West Windsor Township Municipal Building, Room A located in the Municipal Complex, 271 Clarksville Road, Princeton Junction, New Jersey for the work described below. Bid packages submitted prior to the day of the bid opening shall be submitted to the Administration Department in the Municipal Complex. The Township encourages prospective bidders to submit their sealed proposals prior to November 21, 2023, via certified mail or overnight delivery along with requiring a signature. West Windsor is not responsible for bids which are sent for delivery and not received by a Township employee. At conclusion of the public bid opening and after review from Municipal personnel, the bid results along with the pertinent documents of the apparent three low bid submissions will be scanned and posted on the Municipal Website within 48 hours, <u>www.westwindsornj.org</u>.

Specifications, plans and bid documents will be available on or after Monday, October 16, 2023, at 10:00 am, and may be examined from the Administration Department located in the West Windsor Township Municipal Building during the hours of 10:00 am to 4:00 pm, Monday through Friday excluding holidays or obtained upon a non-refundable deposit of \$155.00 per set. The only acceptable methods of payment are cash or a physical check and/or money order. Check shall be made payable to West Windsor Township. Scanned checks are not acceptable. Mailed checks must include a request for documents with the name of the requested solicitation, as well as the Company Name, Mailing Address, Telephone & Facsimile Numbers as well as Contact Person's Name & Email Address. A FedEx number must be provided in order for West Windsor to ship the documents. Cash payments must be submitted in the exact amount.

Bid Proposal SOUTHFIELD ROAD AND SOUTH POST ROAD SEWER CAPACITY IMPROVEMENTS

The work under this contract includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in the contract documents.

The Base Bid includes the construction of an 8 inch sanitary force main and appurtenances from the Assunpink Interceptor at Bruntsfield Drive along Bruntsfield Drive, Galston Drive, Edinburg Road, New Village Road and Southfield Road to the existing sanitary pump station on Block 28.02, Lot 31.01 in West Windsor Township. The project also includes the replacement of 8 inch gravity sanitary sewer with 10 inch PVC pipe upstream of the Southfield Road Pump Station; and pump replacement and upgrades to the comminutor at the South Post Road pump station. Dewatering of excavations and bypass pumping is also required.

Quantities include but are not limited to approximately 11,716 linear feet of 8 inch sanitary force main and appurtenances from the Assunpink Interceptor at Bruntsfield Drive along Bruntsfield Drive, Galston Drive, Edinburg Road, New Village Road and Southfield Road to the existing sanitary pump station on Block 28.02, Lot 31.01 in West Windsor Township. The project also includes the replacement of approximately 1,497 linear feet of 8 inch gravity sanitary sewer with 10 inch PVC pipe upstream of the Southfield Road Pump Station; 12,971 square yards of milling; 1,500 tons of HMA 9.5M64 surface course; 1,200 tons of HMA 12.5M64 base course; 1,155 cubic yards of dense graded aggregate; 305 linear feet of concrete curb; 38 square yards of concrete sidewalk; 13,868 linear feet of 4" wide traffic striping; 3,505 linear feet of 24" wide traffic striping;

1,500 square yards of topsoil, fertilize, seed and mulch; replacement of 3 submersible pumps and appurtenances at the South Post Pump Station; and upgrades to the existing comminutor at the South Post Road pump station.

A bid deposit in the form of a certified check, cashier's check, or bid bond made payable to the Township of West Windsor in the amount of ten percent (10%) of the total amount of the bid, but not to exceed \$20,000.00, must accompany each proposal as a security, which may be forfeited and retained by the Township in lieu of its other legal remedies, if a successful bidder's proposal is accepted by the Township and he shall fail to execute and return to the Township the required contract and/or bonds within ten (10) days after delivery of the prepared contract and/or bond form to him by the Township.

The Township Council reserves the right to reject all proposals in whole or in part or to waive minor informalities as may be permitted by law.
