CHAIRMAN'S COMMENTS AND CORRESPONDENCE

MASTER PLAN WORK SESSION

Draft Circulation Plan Element of the West Windsor Township Master Plan (continued from 2/24/21, 3/3/2021 & 3/10/21)

Chairman O'Brien announced that adoption of Plan will tentatively be July 7, 2021. The Planning Board members reviewed, discussed, and made changes to the draft version of the Plan.

In addition to numerous editorial revisions, the Board considered a new section (5.6) that addresses improvement of various intersections; a new sub-section (5.3.5) that pertains to the proposed roadway on the Atlantic Realty property adjacent to Quakerbridge Road; and a new sub-section (5.7.2) that adds a new connection between Nassau Park and Pavilion shopping center and Canal Pointe Boulevard for mass transit vehicles.

Alison Miller of 41 Windsor Drive, Andrea Mandel of 46 Ellsworth Drive and West Windsor Council President, and John Church of 11 Princeton Place (Zoning Board member not speaking on behalf of the Zoning Board) made several comments/asked questions throughout the discussion. In Public Comment, they spoke about roundabouts vs. a traffic circles, milling vs. paving, bike lanes, high speed and traffic areas, and school crosswalks.

Attorney Muller stated that all Board Members may vote once the hearing starts on the Master Plan, regardless if they missed any previous work sessions.

<u>ORDINANCE REFERRAL FROM TOWNSHIP COUNCIL</u> – Review of Ordinance 2021-11. Add Section 200-236 Cannabis Prohibited Use.

Chairman O'Brien said there was not enough specificity pertaining to the new statute, so the Township was going to optout temporarily until the State's rules and regulations are published. The current land use code indicates no cannabis usage anywhere in the Township. Council will revisit at a later time.

Ms. Geevers made a motion that the Planning Board has no objection to approving Section 4 of Ordinance 2021-11 and notes that it is consistent with the Master Plan; seconded by Mr. Baig.

Elliot Gordon and two green team volunteers, Paula Bal and Angela Castana, described a plan for a new pollinator garden at the West Windsor Community Park. The reusable bag project continues. Environmental Committee Chairman Ephraim Buhks reported on the Zoom program of Greening Together 2021 events sponsored by Mercer County Sustainable Coalition. The events covered Climate Change, Zero Waste, EV Transportation, Stormwater Management--Green Infrastructure, and Spotted Lanternflies. West Windsor Girl Scouts gave presentations on Recycling, Composting, Organic Gardening, and Pollinator Garden.
