Draft Dutch Neck Planning & Zoning Study (a supplement to the 2020 Land Use Plan Element of the Master Plan)

6:54 - Ms. Appelget recused herself from the Hearing.

Planner Novak announced that the most recent document is 03 which incorporates the comments last discussed on November 8, 2023. It is a guideline to help the Township with future zoning regulations. Chairman Karp addressed a letter from Township resident David Donahue regarding ADUs received by the Land Use Office on December 22, 2023. ADUs are not a permitted use in this district, and will not be permitted going forward. Homeowners will have to go to the Zoning Board for a variance.

Planner Novak also addressed the proposed designation of the Historic Zoning in Dutch Neck. (Reference was also made to a second comment letter received on December 22, 2023 from David Donahue.)

Chairman Karp opened the meeting for public comment.

DAVID DONAHUE, 209 South Mill Road: Mr. Donahue said he represented a group of residents. He asked several questions on how this plan will affect any concerns the public may have and how they could have influence in future decisions. Mr. Surtees explained the Township ordinance process. Mr. Donahue said there are 2 large properties is this historic district they are concerned about and expressed what the group does not want. Lot size vs. home size, a burial ground/cemetery, and a 4-way stop at an intersection were also discussed.

MATT WARGO, 412 Village Road: Mr. Wargo said that he does not agree with the installation of signs for traffic calming; there is no enforcement there.

LINDA GEEVERS, 20 Hawthorne Drive, Council President speaking as a resident: Ms. Geevers asked what the process would be if a resident wanted to knock down a home and rebuild on a property. She also recommended that certain phrases be removed from the Plan.

CYNTHIA YODER, 212-214 S. Mill Road: Ms. Yoder asked about the curve at Village Road East and South Mill. Mayor Marathe responded they could check with the Township Engineer.

DAVE KIMMEL, 11 Scott Avenue: Mr. Kimmel asked if the curved road could be made into a crossroad.

Mayor Marathe made a motion to close the meeting for public comment; seconded by Vice-Chairman Hoberman. Voice Vote – All Aye.

Mayor Marathe made a motion to approve the Dutch Neck Planning & Zoning Study with amendments; seconded by Mr. Patel.
