LIAISON REPORT

Affordable Housing Committee – The following report dated December 18, 2024 received from Ms. Bahree was given by Chairman Karp: At the December 5, 2024 Affordable Housing Committee Meeting, it was reported that the New Jersey Department of Community Affairs (DCA) released its Fourth Round (2025-2035) affordable housing numbers for each municipality in late October. Council Member Andrea Mandel provided a lot of detail and the Committee discussed this at great length. West Windsor Township's number stands at 661, which is 4.78% of the regional (Mercer, Monmouth and Ocean counties) prospective need, while New Jersey's total number stands at 84,698. Municipalities also have until January 31, 2025 to adopt and commit to satisfy their Fourth-Round obligation. Municipalities also have until June 30, 2025 to adopt the Housing Element and Fair Share Plan (HEFSP) that addresses their Fourth-Round obligation, and then until December 31, 2025 to enter into a settlement agreement with DCA. March 15, 2026 is the deadline for municipalities to adopt all the resolutions and ordinances to put the HEFSP into effect. The methodology and related provisions associated with the generation of these numbers is available on the State's website in case anyone is

interested. The Committee discussed the pros and cons of having an all-affordable development to satisfy West Windsor's obligation. The Committee has a few members, including Vice-Chair Jean Jacobsohn, with prior experience in this area and is available to lend its combined expertise to the Township if needed.
