Vulnerable Community Presentation by Jeremy Whaley, MPH

Mr. Whaley provided a presentation on Vulnerable Population Assessment for West Windsor.

Members of Council asked various questions which Mr. Whaley and Ms. Swanson responded to.

Ms. Swanson advised that her Division is working on a Resource Directory.

COVID-19 Update

Ms. Swanson advised that this is the second week that our area is in the moderate risk category. She noted that updates will continue to be posted weekly. Ms. Swanson reported that the Governor has come out with new guidelines which need to be reviewed.

President Mandel inquired if a Memorial Day Parade could be done under the new guidelines.

Ms. Swanson advised that all the criteria still needs to be adhered to such as 6 foot distancing and masks need to be worn in large settings.

Ms. Geevers inquired about travel guidelines for residents coming and going from other countries.

Ms. Swanson reviewed the recommendations and guidelines for traveling to and from our area.

Ms. Swanson provided an update on Vaccine Clinics and noted that local clinics will once again be scheduled at the Senior Center between the hours of 10:00 a.m. and Noon. She advised that West Windsor is partnering with neighboring towns to hold clinics for residents who are ages 16 and 17. Ms. Swanson advised that Mercer County will be conducting clinics at the Mercer County Skating Rink starting on March $8^{\rm th}$. She also advised that they have been working on getting homebound residents shots. Ms. Swanson noted that residents can call or email the Health Division and advised that all contact information is posted on

the Township web-site under COVID-19. She noted that clinics may pop-up quickly because there is not a lot of advanced knowledge on when the Township will get vaccine.

Mr. Hersh inquired if we are assisting residents to get shots if we don't have clinics available.

Ms. Swanson advised that her office is assisting residents.

Ms. Gawas noted she has heard that some people who have received their shots are still getting the flu and inquired if this has happened in West Windsor. She also inquired about residents whose family is coming over from India what precautions should be used.

Ms. Swanson advised that those numbers are small but it has happened. She noted that anyone traveling to India should use precautions, masks, social distance, washing of hands frequently and they should use caution when coming back as well.

Council members urged residents to get the COVID-19 shot.

Council and the Mayor thanked Mr. Whaley for his presentation this evening.
