The Project

The proposed project is located in West Windsor Township, Mercer County, New Jersey. Route 571 is a two-lane Urban Principal Arterial. Along the Route 571 corridor (project study corridor), spot improvements have resulted in variable roadway widths. Important issues include traffic congestion and travel and pedestrian safety along the project study corridor. The intent of the proposed project is

to integrate the roadway needs into a comprehensive plan and design the roadway to address existing substandard elements.

Mercer County is in the final design phase of the proposed for Improvements along Princeton-Hightstown Road (CR 571). The project will progress in two (2) contracts:

- Wallace Road/ Cranbury Road (CR 615) to Alexander Road
- Alexander Road to Clarksville Road (CR 638)

The proposed improvements will include reconstruction of the roadway to accommodate two (2) traffic thru lanes, one (1) two-way left turn lane, two (2) bicycle compatible shoulders and pedestrian facilities along each side of the roadway. Additional improvements include ADA facilities, striping, drainage, traffic signals, and roadway geometry.
